

Please Recycle Correctly

Franklin Park residents have embraced the practice of recycling since the Village provided large recycling carts. According to our waste hauler Republic Services, the volume of material recycled per household has increased 15% from 2014. Over 1658 tons were recycled in 2015, an increase of over 200 tons over 2014!

The bad news is that a significant portion of material that residents are putting in the recycling carts is not recyclable. In fact, by placing the wrong items in the recycling bin, the acceptable recycling items become contaminated and must then be hauled away and deposited in a land fill.

The Village has created a Guide to Recycling which details what is and what is not acceptable. Please go to vofp.com to learn more.

> The following items should NOT be placed in the recycling carts: **Plastic bags** Plastic film including shrink wrap Non-food and non-beverage plastic packaging, such as hard casing for compact disks Plastic objects such as toys, plastic knives, forks, spoons and disposable plates Metal hard ware items and fixtures Paper and cardboard with food waste or liquids

Telephone Town Hall Answers Questions On Home Rule

Our Telephone Town Hall meetings always include a great exchange of information. I enjoy getting feedback from our residents on our progress. Residents also have the opportunity to bring any issues in their neighborhoods to my attention. It also is helpful because it gives participants the opportunity to ask questions or to get clarification on Village programs.

During a recent Telephone Town Hall, many residents said they were happy that the Village Board passed a resolution for a Home Rule Revenue Rebate program that would take effect if the Village becomes a Home Rule unit. The program would rebate revenue generated from Home Rule to eligible homeowners annually for a minimum of three years.

- Residential homeowners who live in their home would receive a rebate of no less than \$100 and as much as \$500.

- Senior homeowners who live in their home would receive a rebate of no less than \$150 and as much as \$500 per tax year.

- After the three year rebate of Home Rule revenue, all funds generated by Home Rule will be dedicated to road

Participants also applauded the fact that the Board has held the line on property taxes for the past six years, and thanked us for being fiscally responsible.

A New Revenue Stream

If we become Home Rule unit, the Village would explore imposing a fifty cent per day user fee at parking lots near O' Hare that are located in Franklin Park. These fees would be paid by non-residents who travel on our streets but pay no property taxes towards their upkeep. All our neighboring communities, who are Home Rule, impose such a fee, but at this point Franklin Park cannot. This new revenue stream would not only diversify our revenue sources but also reduce our reliance on property taxes.

I hope that clarifies questions concerning the potential revenue stream.

Village Receives \$90,000 To Fund Facade Rebate Program

In 2015, Franklin Park was awarded \$90,000 in Community Development Block Grant (CDBG) funds to be used for a new Grand Avenue Facade Rebate Program. This is the second consecutive year the Village has been awarded CDBG funds from Cook County. The CDBG program, administered by the U.S. Department of Housing and Urban Development (HUD), distributes funds to communities to solve critical, social, economic and environmental problems facing urban communities.

The goal of the Grand Avenue Facade Rebate Program is to beautify and revitalize the Grand Avenue commercial corridor and encourage economic development in the area. The program provides incentives in the form of rebates for work that contributes positively to the public right-of-way by improving individual storefronts and facades. The specific work may include:

- Repair or replacement of wall materials
- Tuck pointing and masonry
- Complete facade renovation
- Exterior lighting (attached to facade)
- Window/door replacements
- Awnings
- Decorative features

Applicants who plan to complete a minimum of \$5,000 worth of eligible improvements and who meet program requirements will receive a rebate of 25% of the total cost of the project. The maximum amount eligible for rebate is \$5,000 per project. Applicants will be considered on a case-by-case basis in the order they are received until all the program funding is allocated. Applicants that receive a rebate must adhere to HUD regulations and any requirements set forth by the Cook County Department of Planning and Development.
