Flood Improvement Study Underway

The Village has retained Christopher B. Burke Engineering, Ltd. (CBBEL) to study flooding problems at several locations within our Village. The study will collect additional survey information and further analyze existing chronic flooding conditions. The effort will identify cost-effective short-term and long-term actions to alleviate flooding within the Village. Potential solutions under review include optimizing flood control storage at the Jack B. Williams Reservoir

and at the basin called Structure 102, located south of Irving Park Road. In addition to storage, CBBEL is reviewing storm sewer and channel improvements to increase conveyance capacity of both the Village's storm sewers and Silver Creek. Updates will be provided on our website and in the newsletter as the work progresses throughout the spring and summer. As always, we will work to uncover state and federal funding to support these projects.

Electrical Aggregation Referendum on March Ballot

Our Board and staff work hard to protect taxpayer dollars. We keep our operational costs down and seek grants wherever possible to keep program and capitol costs at a minimum. Now, the Illinois General Assembly has given municipalities the ability to seek competitive prices for

electrical services. The process is called Municipal Electrical Aggregation. Many villages have discovered that by combining electrical service for all individual customers into a single bid, consumers have lower electric bills and save money.

Frequently Asked Questions on the March 20th Ballot Referendum on the "Electrical Aggregation Program Referendum"

What is the referendum question on the March 20th ballot?

"Shall the Village of Franklin Park have the authority to arrange for the supply of electricity for its residential and small commercial retail customers who have not opted out of such program?"

What does the referendum mean to me?

The Village Board is seeking to reduce electricity costs for Franklin Park's residents and small businesses. To accomplish this, the Board recently passed an ordinance in support of a referendum being placed on the March 20th, 2012 ballot asking the voters of Franklin Park if they support allowing the Village to implement an Electrical Aggregation program. The Board took this action based on a new state law granting municipalities the power to negotiate bulk electricity purchases from third party suppliers on behalf of its

If the referendum passes, what will it provide for?

The proposed referendum will authorize the Village to create a bulk energy purchasing program to bundle power accounts from households and small business customers. The referendum seeks to empower the Village to negotiate a lower price on their behalf.

If the referendum passes, how will the Village choose a new supplier?

If the referendum is approved, the Village would then have to develop and adopt a Plan of Operation for the aggregation program. Two public meetings are required before the Village

utilize a third-party energy consultant to seek bids from several energy companies. The Village would implement a competitive bidding process to select a licensed alternative retail electric supplier who must be approved by the Illinois Commerce Commission. Bid rates will be compared to Com Ed's current rates and the Village will only select an alternative supplier if their rates are lower than the rate offered by the current supplier, Com Ed. If the Village cannot identify an alternative supplier who offers a lower rate, then the Village would continue service through Com Ed.

Will I be required to utilize the new supplier if the Village selects one?

No. If the referendum passes but you prefer not to be a part of the Aggregation Program, you can opt out and continue to receive electricity from ComEd. Before the Village chooses any power supplier, all residents and small businesses will be notified by mail that they can opt out of the Program by completing and returning a

Will Com Ed no longer be my electric company and will some other company become my electric company?

No. Com Ed would still be responsible for delivering your electricity and managing the infrastructure required to transmit the electricity. Com Ed would also still be responsible for responding to any service requests and if there is a power outage, you would still contact Also, please proceed with caution when Com Ed. could adopt this plan. The Village would new supplier on their bill. The Village would have nothing to do with supplying or delivering your electricity.

Why is the Village pursuing an Electrical Aggregation Program?

Many surrounding municipalities have already initiated similar programs including Oak Park, Orland Park, Highland Park, Frankfort and Mokena or are considering them on the ballot. In communities where the new program is underway, residents have seen savings of 8 to 12 percent on their Com Ed bills. Village officials felt that such an effort could have similar benefits for Franklin Park residents and small business users.

I have been contacted by suppliers who have offered a rate reduction already. Should I consider making a switch now?

Several alternative energy suppliers have been marketing their rates and service offers to residents in Franklin Park via mail and through door-to door contact. While you certainly can enter into an agreement with any of these suppliers, residents should proceed with caution. Please note that none of these suppliers have been selected as the authorized altemative supplier for our Village. You should thoroughly research the rate information they provide with a credible website like www.pluginillinois.org. In addition, you should be aware that some companies are falsely marketing themselves as Com Ed or as a designated affiliate of Com Ed. entering into an agreement with these



Com Ed has proposed a 10-year, \$2.6 billion Infrastructure Investment Plan that calls for a \$1.3 billion investment to strengthen the electric system and another \$1.3 billion to add new, digital smart grid and advanced meter technology to transform the delivery of electricity to homes and businesses throughout northern Illinois. The plan was submitted to the Illinois Commerce Commission (ICC) in January. The company considers it their road map for improved system reliability, enhanced customer service and a 21st century electric distribution system that will support the digital economy and the greener economy of the future.

In the first, five years of the program, Com Ed will reinforce the electric system infrastructure to improve reliability and reduce the frequency and duration of power outages. Significant investments also are aimed at reducing the susceptibility of certain power line circuits to storm-related damage, including high winds, thunderstorms and ice storms. Power lines will be prioritized based on their historical susceptibility to storm-related damage and the ability to provide the greatest customer benefit. The 2012 reliability investments also include inspection and treatment of approximately 133,400

wood utility poles.

The plan also calls for the installation of advanced meters in homes and businesses and is slated to begin later this year, subject to approval by the ICC. Additional investments planned will include modernizing 10 electrical substations through which electric power flows to customers. This upgrade should result in a range of customer benefits, including increased reliability and reduced power delivery expenses. For more information, go to www.comed.com.

Village Wins Grant for a New Fire Truck

The Village of Franklin Park recently learned that the Federal Emergency Management Agency (FEMA) has awarded our Fire Department with a \$333,000 grant to support the purchase of a new fire engine.

"We were all very excited to hear that Franklin Park submitted a winning application," said Fire Chief Steve Iovinelli. "The new, high-tech fire truck will include safety features that will help protect our firefighters and will also allow us to better serve our

community during emergencies."

FEMA received over 5,600 applications from fire departments across the country and Franklin Park was one of the first 40 municipalities to receive the grant. The Village will need to provide a 5 percent match to the grant award, which will be covered mostly by the recent sale of a decommissioned ambulance.

"This grant will allow us to provide a modern, state-of-the art fire engine for our community at a very low cost to the Village," stated Mayor Barrett Pedersen. "Given our location to O'Hare International Airport and that we are the fourth largest industrial district in Illinois, it is critical that Franklin Park have the very best fire fighting vehicles and equipment available. Winning this grant helps us tremendously in this effort."

Currently, the Fire Department has four fire engines with the oldest one held in reserve and which will most likely be retired when the new one arrives. The new fire engine will be ordered this month and the Village should receive it by the fall.







Meals on Wheels Available for Our Seniors

Senior citizens, 60 and older, who are unable to get out to shop for themselves due to physical limitations or who are simply unable to drive, can receive a hot lunch delivered to their home. The Meals on Wheels Program provides a hot lunch five days a week, delivered between 10 AM and 2 PM. A spouse or caretaker living in the household can also qualify even if they are not 60. In addition, frozen meals that can be easily prepared on the weekend, are available. The Program not only provides a hot meal, but it also provides a well being check of the senior every weekday. The Meals on Wheels Program works in partnership with West Suburban Senior Services (WSSS) and conducts a background check on their drivers, many of whom are Village of Franklin Park employees. The cost of a daily meal is a suggested donation of \$3.25-\$3.50 but anyone in need of the program should apply.
