All construction pursuant to the "Foundation Only" permit will be undertaken at the contractors and property owner's risk. The issuance of the "Foundation Only" permit does not insure the immediate issuance of subsequent permits for the remainder of the proposed project. The Village of Franklin Park, its Officers and employees shall not be liable to the contractor or any subcontractor, architects, engineers or the owner for any costs incurred to bring the foundation and subsequent super structure into compliance with any and all codes applicable after the completion of the foundation.
