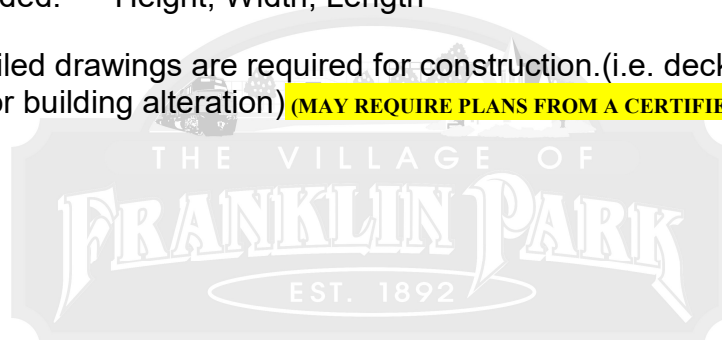
**APPLICATION FOR BUILDING PERMIT:**

- Property Owner’s address, phone number and name printed.
- Description of work.
- Real Estate Index Number (on tax bill) / it starts with a 12 and ends with 0000.
- If owner is doing the work, back of application must signed.
- Contractors need to be listed with name, address and phone number.
- Total cost of job is required.
- Signature and applicant name to be printed at bottom of application with phone number.
- Permit applications take require five days for us to process and approve; you **will be called** when **permit is ready** for pick-up
- Permits cannot be faxed nor can they be accepted via fax for review.
- **Permits for second floor additions on pre-existing slab or crawl space construction require engineering specifications for foundations / footings.**

**TWO (2) COPIES OF AN UPDATED PLAT OF SURVEY IS REQUIRED FOR:**

- Sizes are needed: Height, Width, Length
- 4 sets of detailed drawings are required for construction.(i.e. decks, porches, new construction or building alteration) **(MAY REQUIRE PLANS FROM A CERTIFIED DESIGN PROFESSIONAL)**

## ALL CONTRACTORS ARE REQUIRED TO APPLY FOR A VILLAGE LICENSE FOR ANY WORK DONE IN THE FRANKLIN PARK.

- Complete an “Application of Business License” form.
- Certificate of Liability insurance with The Village of Franklin Park as the holder.
- Need a **“Bond for \$10,000.00” (\$50,000 for demo contractor)** with the certificate holder being: **VILLAGE OF FRANKLIN PARK, 9500 WEST BELMONT AVENUE, FRANKLIN PARK, IL 60131**
- Copy can be faxed to: Department of Inspectional Services at **(847) 671-8790**.
- Original (hard copy) needs to be mailed to this office.
- Fee for license is \$100.00 for fiscal year starting May 1<sup>st</sup> to April 30<sup>th</sup>.
- General Contractor fee is \$250.00.
- Plumbers need to supply a copy of their \$20,000 State Bond or State License. Also require a letter of intent with the location of job, a scope of work and stamped with a corporate seal.
- Electricians need a copy of their “Certificate of Registration”.
- Roofers need a copy of their “State Roofing License”. Page 1
- Sewer/Drain Layer needs a copy of a “City License”. Page 2

**Residential Plumbing & Electrical permits requested to be done “By Owner”, must be accompanied by detailed drawings with specifications, dimensions & proper labeling. These plans will be reviewed by the plumbing or electrical inspectors before any permits are released.**
