## AN ORDINANCE AMENDING ORDINANCE NO. 1112-G-22 TO EXTEND THE PREVIOUSLY AUTHORIZED AND PROVIDED FOR ISSUANCE OF THE SERIES 2011 GENERAL OBLIGATION NOTE OF THE VILLAGE OF FRANKLIN PARK, COOK COUNTY, ILLINOIS

**WHEREAS**, the Village of Franklin Park, Cook County, Illinois (the "Village") is a duly organized and existing municipal corporation created under the provisions of the laws of the State

of Illinois and under the provisions of the Illinois Municipal Code, as from time to time

supplemented and amended.

**NOW, THEREFORE, BE IT ORDAINED** by the President and Board of Trustees of the Village of Franklin Park, Cook County, Illinois, as follows:

Section 1. That the above recital is found to be true and correct and is hereby incorporated

herein and made a part hereof, as if fully set forth in its entirety.

Section 2. That Ordinance No. 1112-G-22, authorizing and providing for the issuance of

\$1,000,000 General Obligation Note, Series 2011, of the Village of Franklin Park, Cook County,

Illinois, is hereby amended by changing the definition of "Final Maturity" to October 18, 2011.

The Designated Officers are hereby authorized to change on the face of the Note the Final

Maturity date to October 18, 2011.

**Section 3.** If any section, paragraph, clause or provision of this Ordinance shall be held

invalid, the invalidity thereof shall not affect any other provision of this Ordinance.

**Section 4.** All ordinances, resolutions, motions or orders in conflict with this Ordinance

are hereby repealed to the extent of such conflict.

Section 5. This Ordinance shall be in full force and effect upon its passage, approval and

publication as provided by law.
