IV. PRESENTATION:

The architect of the 9001 W Belmont project briefly gave the board an overview of the proposed project, a gas station and a convenience store with two adjoining retail spaces - one of which will feature a drive-thru. The gas station will operate 24 hours a day, seven days a week and will feature ten passenger vehicle gas pumps located near the center of the development and three diesel pumps positioned in the northeast corner of the site to minimize impact on neighboring residential properties. A six-foot solid wood fence will provide a visual and noise barrier for nearby residences.
