A RESOLUTION SUPPORTING A CLASS 6B REAL ESTATE TAX ASSESSMENT APPLICATION BY VOLART, LLC FOR AN INDUSTRIAL FACILITY LOCATED AT 10101-10113 WEST PACIFIC AVENUE, VILLAGE OF FRANKLIN PARK, COOK COUNTY, ILLINOIS

WHEREAS, the Village of Franklin Park, Cook County, Illinois (the "Village") is a duly organized and existing municipal corporation created under the provisions of the laws of the State of Illinois and under the provisions of the Illinois Municipal Code, as from time to time supplemented and amended; and

WHEREAS, the President and Board of Commissioners of the County of Cook have enacted an ordinance known as the Cook County Real Property Assessment Classification Ordinance, as amended from time to time (the "Classification Ordinance"), which provides for a tax assessment incentive classification designed to encourage industrial development throughout Cook County by offering a real estate tax incentive for the development of new industrial facilities, the rehabilitation of existing industrial structures and the utilization of abandoned industrial buildings in order to create employment opportunities and expand the tax base; and

WHEREAS, Volart, LLC (the "*Volart*") seeks to acquire a parcel of industrial property with a 34,909 square foot building commonly known as 10101-10113 West Pacific Avenue, Franklin Park, Illinois, identified by permanent index number (PIN) 12-21-311-008-0000, 12-21-311-009-0000, 12-21-311-010-0000, 12-21-311-043-0000, 12-21-311-044-0000 and 12-21-311-053-0000, and hereinafter legally described on Exhibit A, a copy of which is attached hereto and made a part hereof (the "*Property*"); and

WHEREAS, Volart is seeking to acquire the Property to lease it to Cracovia Brands, Incorporated, a related entity, in order to expand its operation, the viability of such expansion

being dependent on the granting of a Class 6B Tax Assessment Classification; and

WHEREAS, Volart has requested that the President and Board of Trustees of the Village of Franklin Park (the "Corporate Authorities") support and consent to the filing of its application for a Cook County Class 6B Real Estate Tax Assessment Classification for the Property, as said term is defined in the Classification Ordinance (the "Class 6B Tax Assessment Classification"); and

WHEREAS, the adoption of a resolution by the Corporate Authorities is required and must be filed by Volart with its application in order for the Property to obtain a Class 6B Tax Assessment Classification; and

WHEREAS, the Corporate Authorities understand that the acquisition and proposed redevelopment of the Property is occurring within less than the 24-month abandonment period as established in the Classification Ordinance but find that the Class 6B Tax Assessment Classification is essential to the revitalization of the Property due to the existence of special circumstances on the Property, while simultaneously ensuring the continued viability and redevelopment of the industrial base of the Village; and

WHEREAS, the Corporate Authorities find that the redevelopment and occupation of the abandoned Property will only occur if the Class 6B Tax Assessment Classification is authorized in order to overcome the special circumstances that are inherent to the Property, which will continue to thwart any viable redevelopment, including but not limited to: (i) the outdated and eroding mechanical equipment within the structure; (ii) the aged and overall worn and obsolete physical condition of the structure; (iii) the unkempt and unsightly structure that have created a blighting effect on surrounding properties; (iv) the ongoing deterioration of the abandoned structure that has an intrinsic chilling effect on the influx of new industrial development within the area; and (v) the erosion of the tax base of the Village and other taxing districts by the loss of industrial enterprises and employment opportunities (the "Special Circumstances"); and

WHEREAS, the Corporate Authorities find that the overwhelming financial barriers created by the Special Circumstances can only be mitigated by the granting of a Class 6B Tax Assessment Classification for the Property and that but for the Class 6B Tax Assessment Classification no economically viable and timely redevelopment of the Property will occur; and

WHEREAS, the Corporate Authorities find that the redevelopment contemplated for the Property will serve the residents of the Village and that without the Class 6B Tax Assessment Classification for the Property it will remain vacant and abandoned and exasperate blight in the area surrounding the Property; and

WHEREAS, to ensure the ongoing viability of the industrial base of the Village, the continuation and expansion of employment opportunities in the Village and to safeguard and further diversify the tax base of the Village, the Corporate Authorities have determined that it is necessary and in the best interests of the Village to approve an application by Volart for a Class 6B Real Estate Tax Assessment Classification for the Property; and

WHEREAS, the Corporate Authorities hereby request that the President and Cook County Board of Commissioners of the County of Cook concur with the findings of the Village to approve the shortened period of abandonment and authorize the Class 6B Tax Assessment Classification for the Property.

NOW, THEREFORE, BE IT RESOLVED by the President and Board of Trustees of the Village of Franklin Park, Cook County, Illinois, as follows:

Section 1. That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

Section 2. The Corporate Authorities expressly support and consent to the filing of an application for a Cook County 6B Tax Assessment Classification for the Property, which is legally described on Exhibit A, and find that without a Class 6B Tax Assessment Classification the Special Circumstances that exist on the Property will not be addressed and the Property will

remain vacant and underutilized, which will not only hinder further development efforts in the area surrounding the Property but will thwart the efforts of Volart to expand its operation in the Village.

Section 3. The Corporate Authorities further find that the granting of the Class 6B Tax Assessment Classification is necessary for an industrial development to remain viable on the Property, which is the subject of this Resolution.

Section 4. If any section, paragraph, clause or provision of this Resolution shall be held invalid, the invalidity thereof shall not affect any other provision of this Resolution.

Section 5. All ordinances, resolutions, motions or orders in conflict with this Resolution are hereby repealed to the extent of such conflict.

Section 6. This Resolution shall be in full force and effect upon its passage, approval and publication as provided by law.

ORDINANCE NUMBER 1213-VC-

AN ORDINANCE AMENDING CHAPTER FIVE OF TITLE FIVE OF THE VILLAGE CODE OF THE VILLAGE OF FRANKLIN PARK, COOK COUNTY, ILLINOIS (VIDEO GAMING TERMINALS)

WHEREAS, the Village of Franklin Park, Cook County, Illinois (the "Village") is a duly organized and existing municipal corporation created under the provisions of the laws of the State of Illinois and under the provisions of the Illinois Municipal Code, as from time to time supplemented and amended; and

WHEREAS, the President and Board of Trustees of the Village of Franklin Park (the "Corporate Authorities") may from time to time amend the text of the Village Code of Franklin Park when it is determined to be in the best interests of the residents of the Village; and

WHEREAS, the General Assembly of the State of Illinois passed the Video Gaming Act (the "Gaming Act"), 230 ILCS 40/1, et seq., to allow certain establishments licensed by the Illinois Gaming Board to operate and allow the use of authorized video gaming terminals; and

WHEREAS, only those municipalities that allow video gaming in accordance with the Gaming Act are eligible to receive a portion of the tax imposed on video gaming terminals; and

WHEREAS, the Gaming Act provides for significantly enhanced law enforcement oversight and all participants in the regulated video gaming industry will be licensed and undergo extensive background checks and investigations; and

WHEREAS, the Illinois Gaming Board is preparing to issue licenses under the Gaming Act; and

WHEREAS, Corporate Authorities have determined that it is in the best interest of the Village and its businesses to pursue all opportunities for revenue for the Village by allowing video

gaming terminals in those establishments licensed by the Illinois Gaming Board.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Franklin Park, Cook County, Illinois, as follows:

Section 1. That the above recital is found to be true and correct and is hereby incorporated herein and made a part hereof, as if fully set forth in its entirety.

Section 2. Subsection 1 ("Gambling Generally") of Section 6 ("Gambling and Related Offenses") of Chapter 5 ("Criminal Code") of Title 5 ("Police and Public Safety") of the Village Code of Franklin Park is hereby amended by adding the following new underlined section to read, as follows:

A. Gambling Defined: A person commits the offense of gambling, unless excepted in subsection B of this section, when the person:

- 1. Plays a game of chance or skill for money or other thing of value, unless excepted in subsection B of this section; or
- 2. Makes a wager upon the result of any game, contest or any political nomination, appointment or election; or
- 3. Operates, keeps, owns, uses, purchases, exhibits, rents, sells, bargains for the sale or lease of, manufactures or distributes any gambling device; or
- 4. Knowingly owns or possesses any book, instrument or apparatus by means of which bets or wagers have been, or are, recorded or registered, or knowingly possesses any money which the person has received in the course of a bet or wager, or receives and possesses money from another for purposes of placing a wager or bet at a different location than where the person received the money and for which the person further receives a percentage based upon the amount of the wager or bet or a fixed fee as compensation for the placing of said wager or bet; or
- 5. Sells pools upon the result of any game or contest of skill or chance, political nomination, appointment or election; or
- 6. Sets up or promotes any lottery or sells, offers to sell or transfers any ticket or share for any lottery; or

- 7. Sets up or promotes any policy game or sells, offers to sell or knowingly possesses or transfers any policy ticket, skip, record, document or other similar device; or
- 8. Knowingly advertises any lottery or policy game or drafts, prints or publishes any lottery ticket or share, or any policy ticket, slip, record, document or similar device, or any advertisement of any lottery or policy game; or
- 9. Knowingly transmits information as to wagers, betting odds, or changes in betting odds by telephone, telegraph, radio, semaphore or similar means; or knowingly installs or maintains equipment for the transmission or receipt of such information; except that nothing in this subsection prohibits transmission or receipt of such information for use in news reporting of sporting events or contests.
- B. Exceptions: Participants in any of the following shall not be convicted of the offense of gambling under this code:
- 1. Agreements to compensate for loss caused by the happening of chance including, without limitation, contracts of indemnity or guaranty and life or health or accident insurance; and
- 2. Offers of prizes, award or compensation to the actual contestants in any bona fide contest for the determination of skill, speed, strength or endurance or to the owners of animals or vehicles entered in such contest; and
- 3. Parimutuel betting as authorized by the law of this state wherein the individual bettor, acting on his or her own behalf, participates at places for parimutuel betting as authorized by the law of this state; and
- 4. Manufacture of gambling devices, including the acquisition of essential parts therefor and the assembly thereof, for transportation in interstate or foreign commerce to any place outside this state when such transportation is not prohibited by any applicable federal law; and
- 5. The game commonly known as "bingo", when conducted in accordance with "an act making lawful the conducting of bingo by certain nonprofit organizations, requiring licensing and prescribing regulations therefore"; and
- 6. Lotteries when conducted by the state of Illinois in accordance with the "Illinois lottery law", enacted by the 78th general assembly; and
- 7. Charitable games when conducted in accordance with the Illinois charitable games act, 230 Illinois Compiled Statutes 30/1 et seq.; and
- 8. Raffles when conducted in accordance with title 3, chapter 31 of this code.

9. <u>Video Gaming Terminals when played, used, owned, maintained or transported as authorized in a licensed establishment which is licensed pursuant to the Illinois Video Gaming Act, 230 ILCS 40/1 et seq., as hereinafter supplemented or amended from time to time.</u>

C. Fine For Violation: Any person convicted of the offense of gambling under the terms of this section shall be fined not less than one hundred dollars (\$100.00) nor more than seven hundred fifty dollars (\$750.00)

Section 3. If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.

Section 4. All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

Section 5. This Ordinance shall be in full force and effect upon its passage, approval and publication as provided by law.

AN ORDINANCE APPROVING AN AGREEMENT BY AND BETWEEN BROADCAST MUSIC, INCORPORATED AND THE VILLAGE OF FRANKLIN PARK, COOK COUNTY, ILLINOIS

WHEREAS, the Village of Franklin Park, Cook County, Illinois (the "Village") is a duly organized and existing municipal corporation created under the provisions of the laws of the State of Illinois and under the provisions of the Illinois Municipal Code, as from time to time supplemented and amended; and

WHEREAS, Broadcast Music, Inc. (the "*BMI*") located at 10 Music Square East, Nashville, Tennessee, is an organization that licenses music rights for the public performance of music on behalf of copyright owners; and

WHEREAS, the Village is required to obtain such licensing in order to legally broadcast musical works in Village buildings and at Village events; and

WHEREAS, BMI and the Village desire to enter into an agreement pursuant to which BMI will grant a music license to the Village.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Franklin Park, Cook County, Illinois, as follows:

Section 1. That the above recitals are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

Section 2. The Agreement by and between the Village of Franklin Park, Cook County, Illinois and BMI, for the term January 1, 2012 through December 31, 2012 (the "Agreement"), a copy of which is attached hereto and made a part hereof as *Exhibit A*, is hereby approved substantially in the form presented to the Village Board, with such necessary changes as may be

authorized by the Village President, the execution thereof to constitute the approval by the Village of any and all changes or revisions therein contained.

Section 3. The officials, officers and employees of the Village are hereby authorized to take such further actions as are necessary to carry out the intent and purpose of this Ordinance and the Agreement.

Section 4. If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.

Section 5. All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

AN ORDINANCE APPROVING AN INTERGOVERNMENTAL AGREEMENT BY AND BETWEEN THE VILLAGE OF RIVER GROVE, COOK COUNTY, ILLINOIS AND THE VILLAGE OF FRANKLIN PARK, COOK COUNTY, ILLINOIS FOR THE ELM STREET IMPROVEMENTS PROJECTS

WHEREAS, the Village of Franklin Park, Cook County, Illinois (the "Franklin Park") and the Village of River Grove, Cook County, Illinois (the "River Grove") are duly organized and existing municipal corporation created under the provisions of the laws of the State of Illinois and under the provisions of the Illinois Municipal Code, as from time to time supplemented and amended; and

WHEREAS, Article VII, Section 10 of the Illinois Constitution of 1970 authorizes units of local government to enter into contract to exercise, combine or transfer any power or function not prohibited by law; and

WHEREAS, the Intergovernmental Cooperation Act, 5 ILCS 220/1 et seq., (the "Act") authorizes units of local government to exercise jointly with any public agency of the State, including other units of local government, any power, privilege or authority which may be exercised by a unit of local government individually, and to enter into contract for the performance of governmental services, activities or undertakings; and

WHEREAS, Franklin Park and River Grove desire to improve Elm Street between Grand Avenue on the south and Belmont Avenue on the north (the "Elm Street Improvement Project"), as said street exists within the jurisdictional boundaries of each community; and

WHEREAS, during the planning process, representatives of both communities have met and agreed upon coordinating the Elm Street Improvement Project with River Grove serving as lead local agency and the parties otherwise agreeing to share the costs of said project on an equal basis; and

WHEREAS, the Village President and Board of Trustees of the Village of Franklin Park, Cook County, Illinois (the "Corporate Authorities") find that it is in the best interest of Franklin Park to approve the Intergovernmental Agreement with River Grove.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Franklin Park, Cook County, Illinois, as follows:

Section 1. That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

Section 2. The Intergovernmental Agreement by and between the Village of River Grove, Cook County, Illinois and the Village of Franklin Park, Cook County, Illinois for the Elm Street Improvements Project, a copy of which is attached hereto and made a part hereof as Exhibit A, is hereby authorized and approved substantially in the form presented to this Village Board, with such necessary revisions, if any, as determined by the Village Engineer, said changes being approved by execution and delivery of such Agreement by the Village President.

Section 3. The officials and officers of the Village are hereby authorized to undertake actions on the part of the Village as contained in the Intergovernmental Agreement to complete satisfaction of the provisions, terms or conditions stated therein.
