THE TREE BOARD/BEE BOARD WILL HAVE INFORMATIONAL TABLES WITH SEEDS FOR GIVE AWAYS
- 2. MS. SPECIAL ANNOUNCED THE FRANKLIN PARK TREE BOARD/BEE BOARD WILL BE HOSTING INFORMATIONAL TABLES AT THE EARTH DAY CELEBRATION HELD ON SATURDAY APRIL 26,2025. THE LOCATION WILL BE AT NORTH PARK FROM 12:00 UNTIL 2:00

- 5. ON BEHALF OF COMMUNITY DEVELOPMENT, MS. SPECIAL REPORTED STAFF HAS IMPLEMENTED A NEW TOOL FOR BUSINESSES INTERESTED IN LOCATING IN FRANKLIN PARK. AN INTERACTIVE MAP SHOWCASING AVAILABLE COMMERCIAL AND INDUSTRIAL PROPERTIES IS NOW LIVE ON OUR WEBSITE. DEVELOPERS, BUSINESS OWNERS, AND BROKERS CAN UTILIZE THIS TOOL TO IDENTIFY POTENTIAL PROPERTIES THAT ARE FOR SALE OR LEASE TO HELP EXPAND OUR GROWING ECONOMY. THIS MAP DOES NOT HIGHLIGHT ANY RESIDENTIAL PROPERTIES IN THE VILLAGE AND IS ONLY INTENDED TO PROVIDE RESOURCES FOR COMMERCIAL AND INDUSTRIAL REDEVELOPMENT. INTERESTED PARTIES SHOULD LOOK FOR THE "AVAILABLE COMMERCIAL & INDUSTRIAL PROPERTIES" BUTTON ON THE VILLAGE WEBSITE TO ACCESS THIS MAP

THIS LANDMARK PROJECT WILL PROVIDE A SAFER WAY FOR MOTORISTS TO BYPASS THE RAILROAD TRACKS NEAR DOWNTOWN FRANKLIN PARK UNINTERRUPTED, GREATLY REDUCING DELAYS AND TRAFFIC IN THE AREA. MADE POSSIBLE THROUGH THE FEDERAL RAIL ADMINISTRATION'S RAILROAD CROSSING ELIMINATION GRANT PROGRAM
