## INSPECTION FEES AND TRANSFER STAMP FEES FOR THE SALE OF REAL PROPERTY IN THE VILLAGE OF FRANKLIN PARK

7-10B-3: FEE FOR THE INSPECTION AND REVIEW: The fee for inspection and review of the deed or document of transfer of ownership shall be one hundred dollars (\$100.00). An additional inspection fee for residential units shall be twenty-five dollars (\$25.00) for the first unit and twenty-five dollars (\$25.00) for each additional unit. In C-1, C-2 and C-3 districts: Commercial Districts, the fee shall be set forth in the chart below; in CM, I-1 and I-2 Districts: Industrial Districts, the fee shall be as set forth in the chart below.
