- II. CALL TO ORDER: President Pedersen called to order the Board of Trustees of the Village of Franklin Park in regular session at 7:00 p.m.
- III. ROLL CALL; ESTABLISHMENT OF QUORUM

IV. PRESENTATION: 911 PUBLIC SAFETY RADIO SYSTEM

Director of Police Mike Witz presented a new 911 Public Safety Radio System. He stated that the current system, Net 16, an analog system, is over 40 year's old. Mr. Witz discussed comparatives between Starcom Radio System, Cook County Radio System, Trait Radio and explored the option of building a digital system in house. Mr. Witz also reported on the benefits of switching to a digital system and funding the project. Mr. Witz reported that the 911 Fund will be able to cover the entire cost and that the system could be ready in the next 3 to 4 months.

 - 1. MS. AVITIA STATED SHE HAD NOTHING TO REPORT ON WATER AND SEWER/FLEET MAINTENANCE
- C. POLICE AND FIRE COMMITTEE (Mr. Ruhl, Chair)
 - 1. MR. RUHL STATED THAT THE VILLAGE RECEIVED A LETTER FROM GOTTLIEB HOSPITAL EXPRESSING GRATITUDE TO FIREFIGHTERS/PARAMEDICS, JASON MURPHY, FRANK OBAYA AND LT. DAN COLANTUANO FOR THEIR PROFESSIONALISM, QUICK ACTIONS, AND BEDSIDE MANNER WHILE ATTENDING A YOUNG PATIENT AT THE HOSPITAL
 - 2. MR. RUHL REPORTED ON AUGUST 29, APPROXIMATELY AT 2 A.M. THERE WAS A FATAL TRAFFIC CRASH AT THE INTERSECTION OF GRAND AVENUE AND MANNHEIM ROAD INVOLVING 6 VEHICLES. MR. RUHL REPORTED THAT THE VEHICLE CAUSING THE ACCIDENT WAS DRIVEN BY A MALE SUBJECT WHO WAS TRAVELING AT A PROJECTED SPEED OVER 100 M.P.H. MR. RUHL ANNOUNCED THAT UNFORUNATELY, ONE OF THE DRIVERS IN THE VEHICLES WAS KILLED. THE SUBJECT WAS ARRESTED ON SCENE AND CHARGED WITH VEHICULAR HOMICIDE

 - 1. MS. SPECIAL REPORTED COMMUNITY DEVELOPMENT COMMISSION MET ON AUGUST 26TH IN PERSON TO DISCUSS POTENTIAL 6B TAX INCENTIVE WHICH IS RECOMMENDED FOR APPROVAL MS. SPECIAL STATED THAT MR. JOHN SCHNEIDER, DIRECTOR OF COMMUNITY DEVELOPMENT, WILL PROVIDE MORE INFORMATION ON THE 6B PROPOSAL DURING DEPARTMENT HEAD REPORTS

 - 1. MR. HAGERSTROM REPORTED ON THE BLOOD DRIVE HELD ON SEPTEMBER 3RD, 15 PEOPLE ATTENDED AND DONATED BLOOD
 - 2. MR. HAGERSTROM ANNOUNCED THAT 10 PEOPLE RECEIVED VACCINES DURING THE FEST. THEIR SECOND DOSE WILL BE ON SATURDAY, SEPTEMBER 18TH FROM 9 A.M. TO NOON AT VILLAGE HALL
 - 3. MR. HAGERSTROM ANNOUNCED THAT LEYDEN FAMILY SERVICES WILL RESUME THEIR IN PERSON DAYS ON WEDNESDAY, SEPTEMBER 22, FROM 9 A.M TO NOON AT THE POLICE STATION
 - 4. MR. HAGERSTROM ANNOUNCED SHRED DAY ON SATURDAY, OCTOBER 16, FROM 9 A.M. TO NOON AT THE POLICE STATION FOR VILLAGE RESIDENTS

VII. STAFF REPORTS AND COMMENTS; DISCUSSION ON AGENDA ITEM

- 1. Mr. David Gonzalez, Village Comptroller, reviewed the July financial report Mr. Gonzalez stated the Village's revenue is down \$263,000 compared to last year due to the property taxes delayed until October 1st. Mr. Gonzales also stated that the Village's expenditures are 6.5 million this year, which includes a payment for 4 new dump trucks
- 2. Mr. Gonzalez reviewed items number 3 and item number 8 that were on the consent agenda for board consideration. Item number 3 allows US Bank to reimburse the village for the trucks previously paid for by the Village, within 60 days

- 3. Mr. John Schneider, Director of Community Development, reviewed item number 8, which is up for board consideration. Mr. Schneider explained that the Letter of Intent on the Consent Agenda, sets forth key terms with WG Hotels LLC. Mr. Schneider emphasized this project still requires Zone Board of Appeals approval, conditional use and board approval for the sale for the redevelopment plans
- 4. Mr. Schneider explained item number 5, which is up for board consideration. Mr. Schneider reported that Mistica Foods is a producer of food products and a family business. Mistica Foods plans to purchase the building that was occupied by Green Bay Packaging and redo the building, which will have an investment of \$4 million of food processing equipment, initially employing 20 people, and will increase the amount of jobs within months
- 5. Mr. Schneider reported on item number 10, on the condition and tax history of the property at 9800 Franklin Avenue
