- 3. FOR THE POLICE DEPARTMENT, MR. RUHL BRIEFLY WENT OVER THE POLICE DEPARTMENT'S JULY REPORT, WITH 3331 RESPONSES TO SERVICE CALLS, ISSUED 411 STATE CITATIONS FOR VIOLATIONS SUCH AS SPEEDING, ISSUED 532 PARKING TICKETS, ISSUED 38 LOCAL ORDINANCE CITATIONS, MADE 92 ARRESTS AND MADE 869 TRAFFIC/PEDESTRIAN STOPS, 27 HIGH GRASS/WEED COMPLAINTS
- 4. MR. RUHL REPORTED THAT JULY 27 WAS NATIONAL SPEED AWARENESS DAY, THE DEPARTMENT MADE 35 STOPS FOR SPEEDING AND ISSUED 19 CITATIONS FOR SPEEDING
- 5. MR. RUHL REPORTED JULY 27 THE US BANK IN BENSENVILLE WAS ROBBED BY TWO SUBJECTS, OFFICER GIULIANO RECOGNIZED THE TWO SUBJECTS AND WAS ABLE TO LOCATE THE SUBJECTS' AND WERE TAKEN INTO CUSTODY
