Answers to Municipal Solid Waste RFP Questions:

The following set of questions were asked by Waste Management:

- 1. Will the Village consider pushing back the due date 2-3 weeks? We could really use more time to fully analyze the request and provide a proper response. No, unfortunately we cannot extend the due date.
- 2. On page 10 of the RFP it says mobile carts have been provided to residents for yard waste by the current contractor. What size yard waste carts are being used? 96-gallon toter for garbage, 64-gallon toter for recycling, and 45-gallon toter for yard waste.
- 3. Can you detail the services provided at the Village Fests? (40) 64-gallon toters for garbage are provided for an event.
- 4. Can you provide the size and frequency of containers at Village facilities?

Village Hall – 2 yd dumpster garbage, 2 yd dumpster cardboard/paper Street Division - 8 yd dumpster garbage, (2) 90-gallon totes recycling Water Division – 2 yd dumpster garbage, (3) 90-gallon totes recycling Fleet Division - 2 yd dumpster garbage, 90-gallon tote recycling Police Dept – 2 yd dumpster garbage, 2 yd dumpster cardboard, (2) 90-gallon tote for recycling Fire Station 1 – 2 yd dumpster garbage, (2) 90-gallon totes recycling Fire Station 2 – (2) 2 yd dumpster garbage, (2) 90-gallon totes recycling, *need to add 2 yd dumpster for cardboard/paper Fire Station 3 – 1 yd dumpster garbage, 90-gallon tote recycling

5. Can you provide tonnages for the last 3 years broken by Trash/Recycling/Yard Waste? Attachment

All municipal buildings are picked up once a week

6. How many multi-family locations are included in this RFP? Do you have what the current services are for those locations? Invoice attached

7. Will the Village consider multiple service days? No, all single and two-family homes need to have their garbage and recycling picked up on one day, preferably Monday. Yard waste can be the next day if not able to pick it up the same day.

The following set of questions were asked by LRS:

- 8. Please provide historical weights for waste, recycling and yard waste for the past three years. Please see answer to question 5.
- 9. Please provide an estimation of the number of homes serviced by curb vs those serviced in the alley. 25% of the homes are curb, 75% are alley.
- 10. Will the Village consider a five-year contract instead of a three-year contract? No, we have included a provision to extend the contract for an additional one to three years.
- 11. The RFP lists 5125 units. Please provide a breakdown of single-family homes and multi-family homes. 5,125 is the number of single and 2-family homes. Please also see answer to question 6 and attached invoice.
- 12. Please provide the service needs for all Village properties that would be included in this work. Please see answer to question 4.
- 13. Please provide the service needs for 'Railroad Daze' Please see answer to question 3.
- 14. Please provide clarity on the Village's current senior program There is no difference between this type of resident and any other resident type. This is how the village bills them for their garbage. The village is billed the same amount from the contractor for these accounts.
- 15. Please provide the number of seniors on the current program 1418 senior accounts.
- 16. Please provide the number of residents who use the low-income and disabled services. The village does not have a number. There is no difference between this type of resident and any other resident type. This is how the village bills them for their garbage. The village is billed the same amount from the contractor for these accounts.
- 17. Will the Village consider extending its current contract by 60 days to allow for a smoother transition? Yes

The following set of questions were asked by Flood Brothers:

- 18. Can the Village provide two years of monthly/annual tonnage totals for refuse, recycling and yard waste? Please see answer to question 5.
- 19. It is my understanding that the Village collection for refuse and recycling is on Monday and the yard waste collection is on Tuesday. Would the Village allow the collection of all three materials to occur on the same collection day? Yes, preferably on Monday.
- 20. Would the Village consider the collection of homes each week on multiple days as opposed to the entire village being serviced on one day? No
- 21. Can the Village provide a list of the multifamily locations serviced under this contract? Please see answer to question 6.
