 - 1. MR. JOHNSON STATED THAT THE VILLAGE COMPTROLLER DAVID GONZALEZ WILL BE GOING OVER FINANCIALS DURING STAFF REPORTS
 - 2. MR. JOHNSON STATED THE VILLAGE HAS SECURED THE TRACK FOR RAILROAD COMPONENT OF THE FALL FEST EVENT, THE VILLAGE IS NOW WORKING TO SECURE A LINEUP OF TRAINS

B. WATER AND SEWER/FLEET MAINTENANCE COMMITTEE (Ms. Avitia, Chair)

- 1. MS. AVITIA STATED THAT THERE HAVE BEEN 11 SEWER BACK-UPS, 84 STREET DRAINS INSPECTED, 28 DRAINS THAT NEED CLEANING, 11 DRAINS TO BE REBUILT AND 2 SINK HOLES THAT NEED TO BE ADDRESS
- 2. MS. AVITIA REPORTED THE GARRA LIFT STATION LOST POWER AND ALL CONTROLS NEEDED TO BE RESET, THE TALBOTT LIFT THAT AN ISSUE WITH PLC, ANDERSON LIFT HAD TO HAVE UPS RESET
- 3. MS. AVITIA REPORTED THAT GRAFFITI WAS REMOVED FROM 12 LOCATIONS, AND THE CREEK HAS BEEN INSPECTED 3 TIMES WITH ONLY DEBRIS PULLED OUT ONCE
- 4. MS. AVITIA REPORTED THAT THE CREW FILLED 26 BAGS OF GARBAGE FROM THE VILLAGE GRASS CUTTING LOCATIONS

 - 1. MR. YBARRA REPORTED THAT POT HOLE PATCHING HAS BEEN COMPLETED FROM THE EAST SIDE TO WEST OF MANNHEIM ROAD, NORTHSIDE AND SOUTH OF GRAND AVENUE AND THE MIDDLE PART OF THE VILLAGE

 - 3. MR. YBARRA REPORTED THAT FORESTRY DIVISION REMOVED 25 TREE TRIMMINGS
